2. Create an Ariba Network account



 NB! Ariba Network accounts are created per legal entity, i.e. your company needs one Ariba Network account per legal entity.



2. Create an Ariba Network account



 NB! Ensure that the address entered is for the specific legal entity that the registration invite has been sent to. Do not enter the address of your headquarter unless the invite has been issued to your headquarter.



2. Create an Ariba Network account



- In the "Product and Services categories" add all categories that your company is able to supply in general. In case you cannot identify an exact category, select the closest match.
- The hierarchy in "Product and Service categories" is based on the United Nations Standard Products and Services Code (UNSPSC) taxonomy of products and services.
